



Pet Waiver & Release of Liability

In exchange for attending the SouthPaws Pet Expo with my pet on June 22 and 23, 2019, located at the Roma Club of Leamington at 19 Seacliff Dr in Leamington, and organised by SouthPaws Training Club, I agree to and acknowledge the following:

1. I agree that my pet has received and is current on the vaccines that are appropriate for my pet.
2. I agree that my pet will be on a leash not exceeding four feet in length.
3. I agree that I will immediately report to Expo staff or first aid if an incident occurs and keep my pet available until I have received instructions from Expo staff or local authorities regarding the required procedures.
4. I agree that my pet is legal to own in the Town of Leamington and conforms to all town by-laws.
5. I agree that I will keep my pet out of any restricted areas, as marked by signage.
6. I agree that I will be in control of my pet at all times.
7. I acknowledge that my pet is not aggressive, is not in heat, and has not had any incidents of biting or showing aggression in the past.
8. I acknowledge that I am the only one responsible for any harm, injury (personal or otherwise), illness, or damage caused by my pet and I agree to indemnify and hold harmless any other person, company, or organisation from any liability resulting from my pet's attendance at the Expo.
9. I agree that my pet has never caused bodily or property damage.
10. I agree to accept full financial responsibility for any and all damages to persons and/or properties as a result of my pet's actions at the SouthPaws Pet Expo.
11. I acknowledge that if my pet displays behaviours that are deemed to be disruptive or dangerous, I may be asked to leave without reimbursement.
12. I agree to keep my snake, reptile, arachnid, or terrarium-dwelling pet contained at all times.
13. I agree that my pet(s) may be videotaped, photographed, and/or recorded. SouthPaws Training Club and SouthPaws Pet Expo shall be the exclusive owner of the results and all proceeds of such media.

I am aware that during the course of my visit at the SouthPaws Pet Expo, certain inherent risks are involved because I am attending with my pet. In consideration for being allowed to attend the SouthPaws Pet Expo with my pet, I agree to assume full and total liability for any and all damages, including, but not limited to, a person, property, or other pet that are alleged to have been caused in total, or in part, by the direct or indirect activities of my pet, me, and/or other persons attending the SouthPaws Pet Expo with my dog. I agree to hold harmless and indemnify SouthPaws Training Club and SouthPaws Pet Expo, the Roma Club of Leamington, the Town of Leamington, and all officers, agents, employees, managers, owners, volunteers, attendees, and other individuals or entities involved with the production of this event from and against all loss, cost, damages, expenses, and liability, from any cause of action that directly or indirectly involves my pet.
